Rebate Requirements and Information

General Information

- Utility account must be current and in good standing.
- All applicants must include: completed application, proof of lawful presence in the U.S, completed affidavit, copy of dated receipt and make/model number from the appliance package.
- Commercial, industrial, and multifamily rebates will be handled on a case-by-case basis.
- Utility accounts are credited for the rebate amount.
- To qualify for the program, **application including copy of your receipt must be submitted within 90 days of purchase.** The Rebate Program is first come, first served. Limited funds are dedicated for the program each year. When funds are exhausted, the program ends.
- The rebate amount will not exceed the actual cost of the washer (minus taxes and labor).
- Fountain Electric & Water customers eligible for \$100.00 rebate; Fountain Electric only customers eligible for \$50.00 rebate.



Washer Information

- Each washer must be brand new (not second hand or refurbished).
- Rebate offer allows for a maximum one washer per single-family residence.
- New washer must be EnergyStar certified

APPLICANTS MUST ATTACH THE FOLLOWING:

- Copy of acceptable form of identification (image must be clear and text readable.)
- Copy of the receipt, make and model, or other identifying documentation from the appliance (do not include original receipt.)

Affidavit of Lawful Presence in the United States
