# Rebate Requirements and Information

## General Information

- Applicant must be a current Fountain Electric account holder. Utility account must be current and in good standing.
- All applicants must include: completed application, proof of lawful presence in the U.S, completed affidavit, copy of dated receipt and make/model number from the appliance package.
- Commercial, industrial, and multifamily rebates will be handled on a case-by-case basis.
- Utility accounts are credited for the rebate amount.
- To qualify for the program, **application including copy of your receipt must be submitted within 90 days of purchase.** The Rebate Program is first come, first served. Limited funds are dedicated for the program each year. When funds are exhausted, the program ends.
- The rebate amount will not exceed the actual cost of the dishwasher (minus taxes and labor).

## Dishwasher Information

- Each new dishwasher (not second hand or refurbished) must have an Energy Star certification.
- Rebate offer allows for a maximum of one dishwasher per single-family residence. The dishwasher must be purchased new, not second-hand (used).

### APPLICANTS MUST ATTACH THE FOLLOWING:

- Copy of acceptable form of identification (image must be clear and text readable.)
- Copy of the receipt, make and model, or other identifying documentation from the appliance (do not include original receipt.)

## Affidavit of Lawful Presence in the United States

Required by Colorado Revised Statute § 24-76.5-103 for City of Fountain's Rebate Applications

I further acknowledge that making a false, fictitious, or fraudulent statement or representation in this sworn affidavit is punishable under the criminal laws of Colorado as perjury in the second degree under Colorado Revised Statute 18-8-503 and it shall constitute a separate criminal offense each time a public benefit is fraudulently received.

Other documents deemed acceptable by the Colorado Department of Revenue may also be provided as evidence to lawful presence.
