Rebate Requirements and Information

- Must be a current Fountain Utilities **electric** account holder. Account must be current and in good standing
- New refrigerator (not second hand or refurbished) must have an EnergyStar certification.
- Rebate is only valid for brand new refrigerators that are 10 cubic feet or greater.
- Newly purchased refrigerator must be replacing an operational (still capable of cooling), 10 cubic foot or greater refrigerator.
- Utility accounts are credited for the rebate amount. Allow up to two weeks for processing.
- Offer allows for a maximum of one refrigerator per single-family residence in a lifetime.
- To qualify for the program, **application including copy of your receipt must be submitted within 90 days of purchase.** The Rebate Program is first come, first served. Limited funds are dedicated for the program each year. When funds are exhausted, the program ends.
- Commercial, industrial, and multifamily rebates will be handled on a case-by-case basis.
- All applicants must include: completed application, proof of lawful presence in the

U.S., completed affidavit, copy of dated receipt and make/model number from the appliance package and Fountain Recycling Center receipt (if applicable).

APPLICANTS MUST ATTACH THE FOLLOWING:

- **Copy of acceptable form of identification (image must be clear and text readable.)**
- **Copy of the receipt, make and model, or other identifying documentation from the appliance (do not include original receipt.)**

Affidavit of Lawful Presence in the United States

Required by Colorado Revised Statute § 24-76.5-103 for City of Fountain’s Rebate Applications
