Summary Overview and List of Attachments:
The City Council approved Ordinance No. 1796, adopting a budget for the FY 2024, on December 12, 2023. Include in that Ordinance was City Council's commitment to affirm and approve the operating mil levy for the General Funcin 2024 once the revised and final assessed property values had been received by the City from the El Paso County Assessor's Office.
The City's Finance Department has received those revised assessed values. They are 19.8% higher than the previous year's assessed values. City Council has indicated their desire to approve a temporary mil levy reduction for the year ended 2024, in order to alleviate the otherwise large burden of the increased taxes due to the increased assessed values.
City Staff is therefore recommending formal affirmation and approval of the General Fund operating mil levy by City Council at 9 mills, which limits the impact of the increased assessed values on the property taxes to approximately 4.85% from the previous year.
Previous Action by City Council: The City Council adopted a budget for the FY 2024 on December 12, 2023, and affirmed and approved the Restricted Public Safety and Heritage Special Improvement District mil levies at that time. City Council also indicated at that time their desire to provide for a temporary General Fund operating mil levy reduction once the revised assessed values were provided.
Background Information
This Resolution amends the FY 2024 budget per City Financial Policies. This amendment will be included with the original 2024 budget to comply with State of Colorado requirements.

RESOLUTION NO. 24-001

A RESOLUTION AFFIRMING AND APPROVING THE GENERAL FUND OPERATING MIL LEVY FOR FISCAL YEAR 2024

WHEREAS, the City Council approved Ordinance No. 1796, adopting a budget for the fiscal year (FY) 2024 on December 12, 2023, and;

WHEREAS, the City Council included the affirmations and approvals of the Public Safety and Heritage Special Improvement Fund mil levies in the Ordinance and;

WHEREAS, the City Council indicated their desire to offer a temporary credit to the General Fund Operating mil levy, for the benefit of the City of Fountain property taxpayers and;

WHEREAS, due to the delay in receiving final assessed property valuations from the El Paso County Assessor's Office, the General Fund Operating mil levy temporary credit could not be determined and;

WHEREAS, the City Council indicated in Ordinance 1796 that the General Fund Operating mil levy would be determined in January upon receipt of the final assessed values and;

WHEREAS, the City staff has now received the final assessed values from the El Paso County Assessor's Office,

And WHEREAS, the City Council wishes to affirm and approve the General Fund mil levy pursuant to Section 9.11(a) of the City Charter, for the FY 2024 budget year and to direct the Finance Department to amend the FY 2024 budget accordingly;

NOW, THEREFORE, BE IT RESOLVED by the City Council:

Section 1. A General Fund mil levy of 9.000 on all taxable property in the City of Fountain, Colorado, in 2023 for collection in FY 2024 is affirmed and approved.

Section 2. That the Finance Department make the appropriate adjustments to the 2024 budget in the City's books and records.
