
Q1 Which of the following describes your connection with the Fountain community (select all the apply)






Q3 What types of services and amenities are lacking in the Old Town, downtown center of Fountain? (select all that apply)


Q4 Do you feel that the greater Fountain area has enough housing options?


Q5 What type of housing would you like to see added to Fountain (select all with write-in option)?


Q6 What type of redevelopment would you prefer to see on the City owned property (select one)? (These are the types of land uses that are allowed in the property's current zone.)


Q7 What is your current impression of the property?






